Stray dog sterilisation centre planned in Chidambaram

Chidambaram, Feb.25: A sterilisation surgery centre for stray dogs will soon be established in Chidambaram Municipality to address the growing stray dog menace in the town. The decision was announced during the Municipal Council meeting held under the chairmanship of Municipal Chairman K.R. Senthilkumar.

Municipal Commissioner T. Mallika and Engineer Suresh were present at the meeting. Senior councillor T. James Vijayaragavan welcomed the move and thanked the Chairman for taking steps to set up the facility, stating that it would help control the stray dog population effectively.

Speaking at the meeting, Vijayaragavan



also expressed gratitude to the Chief Minister of Tamil Nadu for granting Rs.5,000 as rights assistance to women. He noted that development works worth Rs.400 crore are currently being implemented across the town, describing it as a historic phase of growth for the municipality.

DMK councillor Appu Chandrasekar highlighted

that a new bus stand, renovation of the old bus stand and a modern vegetable market have been completed. He said the vegetable market is being maintained in a hygienic manner comparable to airport standards, which has been well received by the public. He added that a Rs.40 crore outer ring road project is under

way to ease traffic congestion, alongside various infrastructure works across all wards.

Congress councillor Thillai R. Makeen stated that projects exceeding Rs.400 crore are being executed across all wards, calling it unprecedented in the municipality's history.
